Objectives and investment policy

Objectives

The fund aims to provide capital growth in excess of the MSCI All Country World (Net Total Return) Index (after the deduction of fees) over any three to five year period by investing in equity and equity related securities of companies worldwide which meet the investment manager's sustainability criteria

Investment Policy

The fund is actively managed and invests at least 80% of its assets in a concentrated portfolio of equity and equity related securities of companies worldwide which meet the investment manager's sustainability criteria (please see the Fund Characteristics section for more details).

The fund typically holds 30 to 50 companies.


